PRC Laws and Regulations

The "State Council Regulations on Simultaneously Flying the National and Regional Flags in the Hong Kong Special Administrative Region" was adopted at the 58th meeting of the State Council Standing Conference on 5th

June and is hereby promulgated for enforcement beginning on 1st July 1997. (Order No.219 of the State Council, signed by Premier Li Peng on June 05, 1997) (Xinhua, 6 June 97, in SWB, 10 June 97; full text: RMRB, 7 June 97)

"Regulations on Governing the Supervision of Public Security Organs", adopted at the 57th meeting of the State Council Standing Conference on 4th June. These regulations shall take effect on the day of promulgation. (Order No.220 of the State Council, signed by Premier Li Peng on June 20, 1997) (Full text: Xinhua, 26 June 97, in SWB, 3 July 97; RMRB, 27 June 97)

A set of provisional regulations on Chinese citizens travelling abroad at their own expense was issued by the Chinese government on June 25, 1997 and will take effect 1st July. The regulation, which was drawn up by the China National Tourism Administration and the Ministry of Public Security and was approved by the State Council, is the first of its kind. (RMRB, XNA, 26 June 97)

Jiang Zemin, chairman of the Central Military Commission, has signed an order on new work regulations for six senior PLA organizations. The new regulations apply to the Headquarters of the General Staff, the General Logistics Department, the Commission of Science, Technology and Industry for National Defence, the PLA Naval Headquarters, the PLA Air Force Headquarters, the Headquarters of the Second Artillery Force, and the Headquarters of the Chinese People's Armed Police Force. The regulations add to former regulations in giving detailed restrictions and functions of different command organizations, methods of organization, military drills, administration, supplies and military science research. Together with an earlier ordinance for PLA headquarters, the six work regulations will form a solid legal foundation for improving operations of senior military organizations in the future. (RMRB, XNA, 24 June 97)

Jiang Zemin, president of the PRC and chairman of the Central Military Commission, promulgated on 30th June the "Order for the Deployment of the Chinese PLA Hong Kong Garrisons in the Hong Kong Special Administrative Region". (Full text: Xinhua, 30 June 97, in SWB, 1 July 97; RMRB, XNA, 1 July 97)
