Newly Appointed Leaders

Cao Bochun

Appointed as member, Standing Committee member and secretary of the CCP Guangxi Regional Committee, according to a decision of the CCP CC. (Xinhua, 15 July 97, in SWB, 17 July 97; XNA, 16 July 97; RMRB, 17 July 97) He had served as deputy secretary of CCP Liaoning Provincial Committee and concurrently as secretary of CCP Dalian Municipal Committee since June 1992. See C.a., 1993/11, p.1122/12. Cao was born in November 1941 in Zhuzhou, Hu'nan Province, and joined the CCP in 1966. In 1963 he graduated from the Zhuzhou Aeronautical Industry Training School. He later served as deputy chief of the Political Division of a branch of the State-run Factory No.331 (1975), director of the Political Department and deputy director of the State-run Factory No.331 (1983), and as deputy secretary, director of the Propaganda Department and secretary of CCP Zhuzhou City Committee (1983-1990). In August 1990 he became secretary of CCP Xiangtan City Committee, and in May 1991 vice-governor of Hu'nan Provincial People's Government. Cao is an alternate member of the 14th CCP CC.

Chen Dongzheng (1)

Appointed vice-chairman of the China Securities Regulatory Committee. (RMRB, 12 July 97)

Chen Yaoxian

Appointed vice-chairman of the China Securities Regulatory Committee and vice-chairman of the Securities Committee of the State Council. He gave up his post as vice-governor of the People's Bank of China. (RMRB, 12 July 97) See C.a., 1996/6, p.626/12.

Guo Dongpo (2)

Appointed director of the Office of Overseas Chinese Affairs under the State Council. (*Ming Bao*, Hong Kong, 23 July 97, in SWB, 26 July 97; RMRB, 15 Aug 97) Guo served as the director of Xinhua News Agency Macau Branch (appointed in 1990) before becoming the chairman of the China Council for the Promotion of International Trade (CCPIT) (appointed in June 1995), which was at the vice-ministerial level. He concurrently serves as Standing Committee member of the 8th CPPCC National Committee (since 1993), as chairman of the China International Economic and Trade Arbitration Commission (since July 1995), and as president of the Economic and Trade Coordination Committee for the Two Sides of the Straits (since January 1996). Guo was born in August 1937 in Jiangdu, Jiangsu Province, and joined the CCP in 1960. In 1963 he graduated from the Beijing Institute of Foreign Trade. He later served as deputy division chief of CCPIT, as Party branch secretary and deputy director of the Printing House of CCPIT, and as vice-chairman of CCPIT and secretary of CCP CCPIT Committee. Guo is an alternate member of the 14th CCP CC.

Jiang Enzhu (3)

Appointed director of the Xinhua News Agency Hong Kong Branch, replacing Zhou Nan. (RMRB, XNA, 26 July 97) Jiang, former vice-minister of foreign affairs, was appointed Chinese ambassador to Britain in January 1996. Jiang was born in December 1938 in Gaoyou, Jiangsu Province, and joined the CCP in 1958. In 1964 he graduated from the English Department of the Beijing Foreign Languages Institute. He later served as 2nd secretary of the Chinese Embassy in the U.K. (1968-1977), deputy division chief, division chief, deputy director and director of the West European Affairs Department under the Ministry of Foreign Affairs (1978-1990), and as assistant minister of foreign affairs (1990-1991). From December 1991 to December 1995, Jiang served as vice-minister of foreign affairs.

Jiang Jichu (4)

Appointed president of the PLA Military Court at the 26th meeting of the 8th NPC Standing Committee on July 3, 1997. (RMRB, 4 July 97)

Jiao Huancheng

Appointed director of the Government Offices Administration Bureau. (RMRB, 12 July 97) He had served as the bureau's deputy director since August 1994. See C.a., 1994/8, p.878/10.

Li Xueyong (5)

Appointed vice-chairman of the State Science and Technology Commission. (RMRB, 12 July 97)

Liao Hui (6)

Appointed director of the State Council's Hong Kong and Macao Affairs Office. (DGB, 10 July 97, in SWB, 11 July 97; RMRB, 15 Aug 97) He had served as director of the Office of Overseas Chinese Affairs under the State Council since April 1984. Liao concurrently serves as vice-president of the China Overseas Exchange Association (since November 1990), as honorary vice-chairman of the Zhongkai Institute of Agricultural Technology (since April 1987), and as member of the Chinese side of the Sino-Japanese Friendship 21st Century Committee (since April 1984). Liao was born in May 1942 in Huiyang, Guangdong Province as eldest son of Liao Chengzhi (he was for a long time in charge of work relating to Taiwan, Hong Kong, and Macau as well as Overseas Chinese affairs inside the CCP), and joined the CCP in 1965. In the same year he graduated from the PLA Military Engineering College. Later he worked in the PLA. In 1983 he served as deputy director of the Office of Overseas Chinese Affairs. Appointed president of the Chinese Academy of Sciences. (RMRB, XNA, 26 July 97) He had served as the academy's vice-president since December 1993. Lu is a member of the 14th CCP CC. For his vita see C.a., 1994/1, p.99/11.

Meng Xiaosi (f) (8)

Appointed vice-minister of culture. (RMRB, 12 July 97)

Shi Wanpeng

Appointed director of the China National Textile Council. He was removed from his post as vice-chairman of the State Economic and Trade Commission (post held since May 1993). (RMRB, XNA, 26 July 97) From October 1991 to March 1993 he served as deputy secretary-general of the former Economic and Trade Office, the forerunner of the State Economic and Trade Commission. See C.a., 1993/5, p.518/12. Shi was born in December 1936 in Tianjin, and joined the CCP in 1971. In 1960 he graduated from the Transportation Department of the Beijing Railway Institute. He later served as chief of the Railway Section of the Transportation Bureau, deputy director of the Transportation Bureau, and director of the Economic and Technology Cooperation

Xu Youfang

Appointed as member, Standing Committee member and secretary of the CCP Heilongjiang Provincial Committee, according to a decision of the CCP CC. (Xinhua, 10 July 97, in SWB, 11 July 97; RMRB, XNA, 11 July 97) Xu had served as minister of forestry since March 1993. For his vita see C.a., 1993/3, p.287/21.

Yin Kesheng (10)

"Animal Epidemic Prevention Law of the People's Republic of China", adopted at the 26th meeting of the 8th NPC Standing Committee on July 3, 1997. This law will take effect as of January 1, 1998. (Decree No.87 of the President of the PRC, signed by President Jiang Zemin on July 3, 1997) (RMRB, 8 July 97)

Premier Li Peng signed a decree, making public the map of the HKSAR that goes effective as of 1st July. The map was approved at the 56th meeting of the State Council Standing Conference on May 7, 1997, in accordance with the Resolution of the NPC on Establishing the HKSAR passed at the 3rd session of the 7th NPC on April 4, 1990. (Order No.221 of the State Council, signed by Premier Li Peng on July 1, 1997) (RMRB, XNA, 1 July 97)

The State Council has decided to revise paragraph one of Article 10 of the "Regulations on the Collection and Management of Compensation Fees of Mineral Resources". (Order No.222 of the State Council, signed by Premier Li Peng on July 3, 1997) (Xinhua, 9 July 97, in SWB, 17 July 97; RMRB, 10 July 97)

"The Tobacco Monopoly Law Implementing Rules of the PRC", following a tobacco monopoly law passed in 1993, have been issued early this month. These regulations shall go into effect on the day of promulgation. (Order No.223 of the State Council, signed by Premier Li Peng on July 3, 1997) (XNA, 20 July 97; full text: RMRB, 11 July 97)

"Provisional Regulations of the PRC on Contract Tax", adopted at the 55th meeting of the State Council Standing Conference on April 23, 1997. The 15-article regulations will become effective as of October 1, 1997. The "Provisional Regulations on Contract Tax", promulgated by the Government Administration Council on April 3, 1950 shall be abolished on the same day. (Order No.224 of the State Council, signed by Premier Li Peng on July 7, 1997) (Full text: RMRB, 22 July 97)

"Regulations on Funeral Management", approved at the 60th meeting of the State Council Standing Conference on July 11, 1997. These regulations shall go into effect on the day of promulgation. The "State Council Provisional Provisions Concerning Funeral Management" promulgated by the State Council on February 8, 1985 shall be abolished on the same day. The 24-article regulations are divided into six chapters: General Principles, Management of Funeral Facilities, Management of the Handling of Remains and Funeral Activities, Management of Funeral Equipment and Articles, Provisions on the Punishment, and the Annex. (Order No.225 of the State Council, signed by Premier Li Peng on July 21, 1997) (Full text: RMRB, 6 Aug 97)

Provisions on handling activities in violation of the stipulations of the "Interim Regulations governing the Selection, Promotion and Appointment of Party and Government Leading Cadres". The regulations shall go into effect on the day of promulgation. (Full text: Xinhua, 14 July 97, in SWB, 18 July 97; RMRB, 15 July 97) A strict regulation was issued on 14th July asking Party members to observe discipline in promotions or dismissals of cadres. Issued by the General Office of the CCP CC, the regulation says that promotions or dismissals can be done only after being discussed by a Party committee instead of being decided by a small number of people. (XNA, 15 July 97)

Addenda

Regulations of the CCP CC and the State Council on Practising Thrift and Banning Extravagance. Party and government departments and officials who spend public funds pursuing extravagant life styles will be severely punished according to the regulations, dated May 25, 1997. CPI (A), CPI (B) and Hang Seng CPI are consumer price indices which cover some 50%, 30% and 10% respectively of urban households in Hong Kong. The base period (i.e. Oct. 94 - Sep. 95) monthly household expenditures of these groups were 4,000-15,999 HK\$, 16,000-29,999 HK\$ and 30,000-59,999 HK\$. The composite CPI is based on the expenditure pattern of all these households taken together.
