He concurrently serves as a member of the CCP CC Commission for Comprehensive Management of Social Security (since March 1991). Ai Zhisheng was born in 1929 in Hanyang County, Hubei Province, and joined the Democratic Youth League and the CCP in 1948. In 1946 he entered Qinghua University where he continued to work after graduation, spending altogether 37 years there mostly engaged in CYL work. After graduating from the Department of Civil Engineering in 1950, he successively served as deputy secretary (1950-1966 and 1979-1983), and concurrently head of the Propaganda Department of CCP Qinghua University Committee (1950-1956), director of the Office of CCP Qinghua University Committee, secretary of CYL Qinghua University Committee (1956-1958), secretary of the CCP Committee of the Nuclear Energy Technology Institute of Qinghua University (1979-1980), and vice-president of the university (1980-1983). From 1983 to 1986 Ai served as deputy secretary-general of the State Council. In June 1985 he was appointed minister of radio and television (the ministry was renamed Ministry of Radio, Film and Television in January 1986; Ai remained its minister and held this post until May 1994). Ai Zhisheng is a member of the 14th CCP CC.

Cameroon (Aug 04)

China and Cameroon signed an agreement on the cooperation programme in the field of higher education and a protocol on cooperation in education in Yaoundé. (RMRB, 7 Aug 94)

Ethiopia (Aug 04)

A medical cooperation agreement between China and Ethiopia was signed in Addis Ababa. The agreement was signed by Chinese ambassador to Ethiopia Ji Sen and Ethiopian Deputy Minister of External Economic Cooperation Israel Kidane-Mariam. Under the agreement, a 13-man Chinese medical team will come and work in a hospital in Nazret for two years, and China will provide medicines and medical equipment for the medical team on a grant basis. Mali (Aug 26)

An agreement under which the Chinese government offered loans to the Malian government was signed in Beijing. Premier Li Peng and visiting Malian Prime Minister Ibrahim Bombacar Keita attended the signing ceremony. (XNA, 27 Aug 94)

Mauritius (Aug 01)

An agreement on prevention of double taxation and tax evasion was signed in

Beijing by Chinese Minister of Finance Liu Zhongli and his Mauritian counterpart Ramakrishna Sithanen on behalf of their respective governments. (XNA, 2 Aug 94; RMRB, 7 Aug 94)

Myanmar (Aug 13)

A memorandum of understanding between the Chinese government and the Myanmar government on border trade was signed in Yangon. Li Guohua, Chinese vice-minister of foreign trade and economic cooperation, and U Aung Thuang, Myanmar deputy minister of trade, signed the memorandum on behalf of their respective governments. An agreement on border trade, signed by the Import and Export Corporation of Yunnan Province of China and Myanmar Import and Export Corporation in 1988, marked the beginning of the border trade between the two countries. (XNA, 14 Aug 94)

Pakistan (Aug 04)

China and Pakistan signed a protocol of understanding on economic, trade and scientific cooperation in Islamabad. The agreement was signed at the conclusion of the three-day 9th session of Pak-China Joint Economic Committee. Li Guohua, Chinese vice-minister of foreign trade and economic cooperation, and V.A. Jafarey, advisor to Pakistan Prime Minister Benazir Bhutto on economic affairs, signed the agreement on behalf of their respective governments. (XNA, 5 Aug 94)

Pakistan (Aug 15)

China donated 6,007 cartons of relief goods, worth 15m Rupees (500,000 US\$), to the Afghan refugees in Pakistan. (XNA, 16 Aug 94)

Philippines (Aug 11)

The Chinese and Philippine governments signed the 1994-1995 executive program for the China-Philippines cultural agreement in Manila. The program was signed by Gao Yunjia, assistant minister of culture of China, and Marcial Salvatierra, assistant secretary of education, culture and sports of the Philippines. Under the program, the two countries will further strengthen cultural, education, sports and academic ties based on the cultural agreement signed in 1979. (XNA, 12 Aug 94)

Uganda (Aug 09)

China has supplied a batch of industrial equipment worth 1m US\$ for Ugan-

da to develop its small-scale industry. (XNA, 10 Aug 94; RMRB, 11 Aug 94)

United States (Aug 29)

Chinese Minister of Foreign Trade and Economic Cooperation Wu Yi and visiting US Secretary of Commerce Ron Brown signed an agreement on the framework for cooperation under the business development working group of the US-China Joint Committee on Commerce and Trade. "Arbitration Law of the People's Republic of China", adopted at the 9th session of the 8th NPC Standing Committee on August 31, 1994. The law will be implemented from September 1, 1995. (Decree No.31 of the President of the PRC, signed by President Jiang Zemin on August 31, 1994) (Full text: RMRB, 1 Sep 94)

"Auditing Law of the People's Republic of China", adopted at the 9th session of the 8th NPC Standing Committee on August 31, 1994. The law will be implemented from January 1, 1995. (Decree No.32 of the President of the PRC, signed by President Jiang Zemin on August 31, 1994) (Full text: RMRB, 1 Sep 94)

China has worked out a new regulation regarding foreign investment in its burgeoning real estate industry, according to sources at the Ministry of Construction. The regulation, jointly mapped out by the ministries of construction and foreign trade and economic cooperation, stipulates that China encourages foreign investment in the development of land for industrial use, renovation of old housing and

construction of residential buildings. China has over 28,600 real estate companies, 4,000 sino-foreign real estate joint ventures and another 800 real estate firms solely owned by foreign businessmen. (XNA, 16 Aug 94)

"Regulations on asset-evaluation for rural enterprises" have recently been issued by the Rural Industry Bureau of the Ministry of Agriculture. (XNA, 17 Aug 94)
